

MINUTES CENTRAL REGION CONFERENCE OCTOBER 2-3, 1993 MILWAUKEE, WISCONSIN

- A. Participated in the May 31, 1993 rededication of the GAR Opera House. The House, in which the local GAR Post met, had been recently restored by the Memorial House Foundation, Valparaiso, IN at a cost of approximately \$100,000. The structure is now sealed against outside weather but will likely require nearly \$500,000 to restore the interior. The original dedication was Nov 27, 1893.
- B. Has worked on the project to designate US 12 as the Iron Brigade Hwy. Indiana was the first of several states to successfully have a legislative resolution passed.

Alan Nolan, a brother and author of the book on the Iron Brigade, has participated in the project. First indications are that the first sign will be at visitors park where the Indiana National Lakeshore is located. Other states involved in this effort are Michigan, Illinois, and Wisconsin.

- C. Participated in February in school settings with life skill teaching. The focus was learning how to use the National Archives to find a Civil War ancestor.
- IV. Secretary Doug Park
- A. Discussed the proposed CRC Ritual which was prepared at the request of members of the 1992 CRC. The Ritual includes provision for Opening, Closing, and Officer installation Ceremonies as well as an Order of Business.
- B. Discussed efforts in Michigan relating to designating US 12 as the Iron Brigade Hwy. A legislator, a brother of the Order, has introduced appropriate language and the Deputy Director of the Mi Dept. of Military Affairs has called to relay the support of his department for the effort. Due to prior designation of U.S. 12 for another worthy association, co-designation may be the answer in Michigan.
- C. Recently participated with the Questers, a group chartered in 1944 in Pennsylvania who restore items of antiquity. A chapter in Michigan adopted a project of restoring a GAR monument in Newburgh Cemetery, Livonia, MI. The monument which commemorated a GAR Post named after two brothers who died at Gettysburg, had nearly collapsed and was restored and dedicated in a ceremony last month. The color guard was composed of members of Gov. Crapo Camp #145, Flint. Our two organizations, previously unknown to each other, benefitted from the joint exercise. We were able to discuss membership and camp organization with many individuals.
- D. Particpated as a speaker at the 125th Anniversary celebration of Gen. Logan's Order #11 at the Michigan State Capitol, 30 May 1993.

Commander Shaefer called upon SVC-in-C Kelth Harrison to lead the resumption of the 1992 discussion of membership recruitment and retention. Bro. Harrison summarized the discussion to this point, i.e. fundamentals are a) publicity, b) follow-up, c) amenities like certificates, dinner programs, etc. and d) retention through planned activities. Keith said the National JVC-in-C recruiting program fielded 702 names of interested individuals and the SUVCW experienced a net gain of 433 members (3148 total members at year's end). Keith said advertising will increase next year and will include the Vietman Magazine. The American Legion Magazine has a subscription of 2,900,000 and will also be investigated.

The key to membership building is follow-up by camps. Some camps are very active and others doing nothing.

JVC-in-C Dave Medert discussed his program to require quarterly reports from Dept JVC on membership recruiting starting Jan. 1, 1994. He restated the importance of follow-up and said a public profile program like the Rosehill Cemetery rededication by Custer Camp No.1, Illinois is a good example of how to successfully recruit. He suggested using camps-at-large if applicants just want to represent an ancestor. Also, the idea of auctioning off a \$100 bill peaks a lot of interest, generates \$300 to \$500 of revenue and involves women as well as men. Most importantly, Dave said to include dinner or other social functions along with the camp meeting. This formula has led to gatherings of 50-60 out of a membership of 88.

Tom Johnson said this was a fine discussion led by Keith but many of these ideas had been heard years ago. The difference is today the national organization supports this recruiting effort and the infrastructure is now there.

Doug Park offered the idea of a computer-printed national membership card which had been first discussed with PCC-in-C Bud Atkinson Fall, 1992. Bud liked the idea and asked that it be explored. Doug and Dick Williams have not yet researched this but it would seem likely to have advantages over the handwritten and typed system now in place, especially if member information were to flow through departments. The processing could take many forms but, essentially, computer-printed cards, which could be stamped/authorized at the local level, much like the American Legion, would offer many advantages. Ron Aronis said the present card doesn't fit a wallet, nor the scroll space of a typewriter. Jim Mueting offered that the tri-color membership certificate does not fit a typical printer either. George Nuoffer said it was time to get out of the 1940's and into the 1990's.

Commander Shaefer rose to thank everyone for the lively discussion. She also said the tour guide this morning had expected non-enthusiastic old men in their 80's. She said h was quite surprised at our enthusiasm.

Recess was called by Cdr. Shaefer at 4:15 pm.

The Central Region Banquet was held at 6:30 pm in the Hotel's Green Tree Library. Following the dinner, Toastmaster Tom Johnson introduced Lewis P. Mallow, Jr. who presented "Gettysburg, the Battle and the Speech." This very excellent program was followed by comments by Commander-in-Chief Allen Moore. Commander Moore referenced recent activities at the rededication of Libby Prison, the restoration of 100# cannon in a local cemetery and his desire that his administration be focused on recruiting and member retention. Following this, the host department held a raffle. Nearly everyone was a winner and some, like Keith Harrison, won more beans than required.

SECOND SESSION OCTOBER 3, 1993

The second session of the Central Region Conference was opened by Commander Shaefer at 9:30 am in the Manchester East Green Tree Library.

After the formal opening, Keith Harrison resumed leadership of the recruiting discussion from the previous session. Bro. Harrison moved the CRC request the Commander-in-Chief assign to the National Membership Committee the task of developing a recruiting manual to be presented to the 1994 National Encampment in Lansing and, following adoption, said manual would be made available to all camps and departments. Jim Lyon seconded and suggested ideas from the 1926 SUVCW and 1988 SCV manuals might be explored. Tom Johnson rose on point of order to state the motion should be considered during the business session. Commander Shaefer agreed to delay the vote on the motion.

Kelth Harrison reiterated the four basic components in a recruiting package and said the principal point for success will be adoption by the National Encampment.

Dave Medert asked about developing minimum standards for recruiting members. Everyone agreed this area is worthy of development. This should be included in the manual mentioned by Keith Harrison.

Tom Johnson rose to lead the discussion on the Constitutional Impact of the Civil War. Tom prepared by laying out the background of U.S. Supreme Court members since John Marshall's tenure ended with Marshall's death in 1834. The Court President Lincoln inherited upon his inauguration was divided in its support for the President but he had 3 and, ultimately, 4 vacancles to fill during his term. The men who ultimately filled these vacancles did not always support their benefactor. Some of the decisions facing Lincoln's Court and generated by the Civil War were:

- -The blockade of southern ports
- -Lincoln's call for 22,000 soldiers and 18,000 seamen
- -The suspension of the writ of habeas corpus (Maryland)
- -Burnside's arrest of one making seditious remarks during war
- -The Conscription Act of 1863

Following this excellent overview, Ross Dunlop added to the discussion by analyzing the source of our personal rights. These are derived not only from the U.S. Constitution but from English Common Law. The example was the case involving Lambden Milligan where Lincoln appointee David Davis wrote that military courts had violated the writ of habeas corpus and Milligan should have been tried in civil courts. It is interesting to note Davis rode with Lincoln prior to 1860 on a circuit in Illinois and was Lincoln's campaign manager previously but disagreed on this important point with his long time legal ally. Also noteworthy was exparte Milligan gave the U.S. Supreme Court an opportunity to regain credibility lost as a result of the Dred Scott decision.

More in-depth material on this subject can be found in Davis' biography, Lincoln's Manager written by William King. Another excellent reference is Lincoln's Supreme Court, David M. Silver, University of Chicago Press, 1950.

Commander Shaefer thanked all the presenters for excellent research and leadership in this year's discussions. She called for a report of the Auditing Committee.

Bro. Harrison announced the treasurer's books were all in order. Jim Lyons moved to accept the report. Tom Johnson seconded. Motion carried.

As no resolutions were offered for consideration, Cdr. Shaefer offered that the standard courtesy resolutions which are sent to the hotel and host department be considered for adoption. Gary Gibson moved to have these sent. Keith Harrison seconded. Motion carried.

Chairman Ron Gill presented the Nominating Committee report. The slate of nominations were:

Keith Harrison moved to accept report. Dick Williams seconded. Motion carried. Jim Lyons moved the slate be elected as a unanimous ballot. Tom Johnson seconded. Motion carried.

Cdr Shaefer asked the Secretary to read the motion made previously by Keith Harrison on the membership manual. This was done and the previous second noted. Motion carried.

Tom Johnson rose to lead the discussion on the Constitutional Impact of the Civil War. Tom prepared by laying out the background of U.S. Supreme Court members since John Marshall's tenure ended with Marshall's death in 1834. The Court President Lincoln Inherited upon his inauguration was divided in its support for the President but he had 3 and, ultimately, 4 vacancies to fill during his term. The men who ultimately filled these vacancies did not always support their benefactor. Some of the decisions facing Lincoln's Court and generated by the Civil War were:

- -The blockade of southern ports
- -Lincoln's call for 22,000 soldiers and 18,000 seamen

Cdr Shaefer asked the Secretary to read the motion made previously by Keith Harrison on the membership manual. This was done and the previous second noted. Motion carried.

Keith Harrison moved the CRC accept the ritual as prepared by Doug Park and amended by written comments by Keith Harrison, Gary Gibson, and Peggy Shaefer. Tom Johnson seconded. Motion carried.

Doug Park moved the CRC pay for a rubber stamp for the CRC letterhead to save on preprinting envelopes. Jim Lyons seconded. Motion carried.

Ellinore Johnson passed out the Treasurer's report. After discussion, Jim Lyons moved to accept the report. Gary Gibson seconded. Motion carried.

Jim Lyons moved the Treasurer be authorized to pay enumerated bills pertinent to the conference. Tom Johnson seconded. Motion carried.

Cdr. Shaefer asked for consideration of the location of the 1994 and 1995 CRC. Motion by Jim Lyons to hold the 1994 CRC in Galena, Illinois and the 1995 CRC in Indiana, city to be named. Tom Johnson seconded. Motion carried. The subject of the 1994 CRC will be "U.S. Grant-Before and After". Tom Johnson will lead discussion.

Tom Johnson moved the CRC thank the current officers for a job well done. Keith Harrison seconded. Motion carried. Cdr. Shaefer thanked all who came and made a delightful conference. She asked if Gary Gibson had chosen an installing officer for the Officer Installation. Gary asked C-in-C Moore to preside.

The slate of elected officers to serve during 1993-1994 were installed per ritual.

Commander Gibson thanked everyone for their attendance and past support. He then closed the 1993 Central Region Conference per ritual.
