Report of Officers

Commander Teller called a short recess. The Bible was closed. The meeting was reconvened and the Bible opened.

Resolutions Committee: Barbara Knopke, presented the resolutions: 1) Thank You notes to: A. Holiday Inn South, St. Louis, MO B. Host, SUVCW Department of Missouri C. Growler's Pub. 2) Donation to Department of Missouri of \$200.00 for a project of their choice.

<u>Audit Committee:</u> Jack Shaw commended the treasurer for accuracy and completeness. The treasurer's report was accepted.

Report of Nominating Committee: Jim Knopke announced the candidates. Commander, Walter Busch. Senior Vice Commander, Lee Ann Teller. Junior Vice Commander, Michael Beck. Secretary/Treasurer, Jack Shaw. Commander Teller called for other nominations from the floor. Commander Teller, receiving no further nominations called for a vote of one for each officer to be cast and recorded. The officers elected for 2008-2009: Commander, Walter Busch, MO; Senior Vice Commander, Lee Ann Teller, IN; Junior Vice Commander, Michael Beck, IN; Secretary/Treasurer (3 year term), Jack Shaw, IN.

Commander Alan Teller called for By Laws Committee Chairman, Donald Palmer, to pass out copies of the by laws. The by laws passed out were with revisions and deletions along with the original wording. Don told of the responses he received. Some rather heated. Don offered the option of continuing with the by laws or not having by laws. Everyone wished to continue to establish by laws using the existing framework. Don

went through each article and section one-by-one until an agreement could be reached. A lot of revision wording and deletion of items was done. It took much time and discussion among attendees. Alan Russ moved to accept the by laws as amended. Motion was seconded by Bob Petrovic; passed. A final updated and revised copy of the by laws will be presented at the next conference. An attachment of the by laws will be filed with the secretary's report. The by laws will also be held by the Historian for future reference. In conjunction with the by laws, Department dues will no longer be paid. A registration fee set by the conference will entitle all registered attendees the right to vote.
