Minutes of the October 2, 2010 CRA Conference

Alan Teller made a motion that the Minutes would be accepted, as written. It was seconded by Walter Busch and approved by consensus of the attending members.

OFFICERS REPORTS

Commander:

Commander Petrovic reported that he Represented the Central Region Association at Gettysburg Remembrance Day, Lincoln Tomb Ceremony, Springfield, two Signature events in Missouri, and the SUVCW, National Encampment. He also reported about the research he did through the year on obtaining an E.I.N. To open our bank account and conduct our financial business.

Senior Vice Commander:

Senior Vice Commander, Donald Shaw, reported that he attended Gettysburg, the Lincoln Tomb Ceremony and The 2011 National Encampment

Secretary/Treasurer:

Secretary, Jack Shaw reported to the members that the CRA Bank account had been closed. The balance opened at \$1,347.12 and closed at \$878.56. A report, explaining all financial activity was made available to the attending members. Secretary Shaw went on to report all records were in order.

Historian:

Historian, Alan Teller reported that he did a minimum amount of work to advance the historical data Collect over the past year, however, Historian Teller went on to report that he did conduct a survey that the 2011 Conference tasked him with. The survey was sent out on October 8th 2010 to those who have attended CRA conferences in the past, but did not attend the 2010 Conference. The survey was sent out to 46 members and he received 14 replies. The replies came from Iowa, Indiana, Kansas, Nebraska, Ohio and Wisconsin. Historian Teller also reported that he worked with Commander Teller to arrange the 2011 CRA Conference in Rockville, Indiana.

During the Officer's reports, Past CRA Commander, Lee Ann Teller addressed the Allied Orders Data Base committee. Past CRA Commander, Teller went on to explain the purpose of the Data base and it's obstacles.

OLD BUSINESS

Walter Busch opened the discussion, with digitizing the old CRA records on microfilm. Past CRA Commander, Busch went on to explain that he had currently been working with a company, Microtek and had produced a digital, diazo master copy of the CRA records. Alan Teller Made a motion to keep the diazo copy with the current Secretary/Treasurer's files. The records would contain the CRA minutes from 1940, to 2009. JV C-in-C Freshley added that the information be added to the web page. Mike Beck seconded a motion on keeping the diazo copy with the Secretary/Treasurer. The motion was passed by consensus of the attending members.

Alan Teller brought forth a discussion pertaining to the original hard copies of the records. A. Teller recommended storing the records at Ball State Archives. He added that he would check with Ball State. Don Palmer also suggested storing the records at the National SUVCW Headquarters.

A discussion was on the floor pertaining to obtaining an E.I.N. Judy Rock Made a motion that we would pursue a CRA E.I.N. The motion was seconded by Don Shaw and passed by a consensus o

of the attending members.

Commander Petrovic presented an award to Alan and Lee Ann Teller for their continued work keeping the Central Region Association Active.

No other nominations were received from the floor. The Secretary was ordered to cast a vote for the slate as provided by the committee.

NEW BUSINESS

CRA Commander, Robert Petrovic opens with a discussion on future meeting locations for the Central Region Association. Walt Busch suggested Bardstown, Kentucky. Although no members of the department of Kentucky were present. Cindy Norton volunteered arranging the 2013 conference in Ohio. The end result of the discussion was:

Walter Busch made a motion to accept the four year CRA schedule. Judy Rock seconded the motion and was passed by a consensus of the attending members.

Don Shaw seconded the motion and it was passed by a consensus of the attending members. It must be voted on again in 2012 to become part of the bylaws.

Don Palmer Discussed his concern of the approximate \$330.00 loss on the CRA Treasury funds. It was decided from a suggest by Walter Busch that a collection should be taken at the ongoing conference. An Amount of \$160.00 was collected and later deposited in the treasury fund.

CRA Commander Petrovic opened a discussion to improve the CRA web page.
