The Central Region Conference

The Central Region Association was founded with the purpose of "bringing the Departments closer together in the true spirit for which they were organized, and to receive information and inspiration for the renewed efforts" when participants return home. Each Camp in the Region was asked to send at least one representative and both Camp and Auxiliary and Department and Past Department officers were encouraged to attend.

Dwindling membership and other organizational concerns following World War I led some SUVCW Department to form Regional Associations by the mid-1930's. Many of these Departments had already experienced success with similar organizations on a much smaller scale within their own boundaries. Decades earlier, Camps, in a particular geographical area had found it advantageous to form districts or associations.

In 1940, a "Tri-State Conference" was held in LaCrosse, Wisconsin. By 1941, the "Upper Mississippi Valley Region," as it was then called, included four Departments: Minnesota, Wisconsin, Illinois, and Iowa. By the 1950s, as highways were improved, freeways were built and travel became more popular, the Departments of Indiana, Michigan, Ohio, and Colorado were included and the association became known as the "Central Region." In 1960, the Departments of Missouri and Kansas were welcomed into the Central Region. (when were the other states added? Kentucky, Tennessee, Nebraska, & Wyoming. No record in the minutes.)

In 1959, the upcoming Civil War Centennial caused the Central Region to re-examine its purpose. Under the leadership of Wisconsin's Department Commander, Thomas L. W. Johnson, over the next 35 years, the Central Region Conference included a round table discussion on a Civil War topic or an issue affecting the Allied Orders or both. "The Challenge of Patriotism," "The State of Our Order," "Preserving Historic Sites," were discussed, as were "The Civil War in Indiana," "Gen. Grant Before and After the Civil War," and "The GAR in Wisconsin." A Saturday morning tour of an historic site and a Saturday evening banquet with a guest speaker became regular features.

By the early 1990s, a renewed sense of purpose and a growing membership were signaling changes in the SUVCW. A new generation of members was being elevated to leadership positions within the Department and National organizations. Some of these members were effective leaders in the Central Region and the conference program took a slightly new direction. In 1993, Michigan's J. Douglas Park adapted the National Ceremonies and Order of Business to be used during the Central Region Conference. In 1997, "how to" seminars and presentations started to appear in the Conference program with regular frequency. These were aimed at strengthen the basic knowledge and skills of those in the Region's Camps and Auxiliaries. The following year the Conference voted to create a committee for "Training and Steering" the Region Conference into the next century.

Today, the Central Region is one of only two surviving regional associations within the Allied Orders. The other is the Eastern Regional Association.

SAVE THE 30 INDIANA BATTLE FLAG OF THE CIVIL WAR
We owe it the respect and honor it deserves, due to age it is in
NEED of restoration.

How we came to be in possession of the 30 Ind. Inf. Battle Flag.
Captain James Mc Clean Preston was present at the end of the war by his comrades the flag,
upon
his death in 1922, it was placed on his coffin. It then became the property of Preston Museum
in Orleans, NE. In 1987, Elmer and Joan Bennett, was given the flag by Memorial Library, Joan
Bennett,
is a Past National President of the Woman's Relief Corps. They in turn in 1987, presented to
Woman's Relief Corps Museum in Springfield, IL. The cost of saving the

THE 30 IND. INF. BATTLE FLAG

The flag was presented to the 30th by the Ladies of Lima, Ind. on July, 1861. The 30th was
organized and mustered in for 3 years, at Fort Wayne, Ind. on Sept. 24, 1861
The flag was proudly carried into battle at SHILOH, SIEGH OF CORINTH, STONE RIVER,
TULLAHOMA,
CHICKAMAUGA, ATLANTA CAMPAIGN, RESACA, KENNESAW MT. SIEGE OF
ATLANTA, JAMESBORO,
SECOND BATTLE OF FRANKLIN, BATTLE IF NASHVILLE.

The 30 th lost 412 men, 4 officers and 133 enlisted 1 officer and 274 enlisted died from
disease

As a footnote one of the Officers in the 30th was awarded the MEDAL OF HONOR for his action
at Atlanta, GA. Henry Ware Lawton . Born 1843 in Maumee, Ohio. Moved to IN. in 1843 Died
1899.

He fought in Civil War, Apache War, Spanish American and only officer killed in Philippine War.
The city of Lawton OK. is named after him (PS my niece taught in Lawton and alot of my family
from OK)


